Installation Instructions

Street Light Bar (Part # 130010)
04-08 Ford F150

NOTE: Please read instructions entirely before installing this product

Light Bar	1	15/16" Nuts	2
1/2" x 5/8"	2	2" Washers	2

Step 1: Locate the two plastic inserts in each corner of the bumper opening, remove and discard. This will expose a factory mounting location behind the bumper on both sides. **NOTE:** The mounting locations will be a round or oval hole through a metal plate on both sides. (Fig A)

Remove plastic/mesh inserts at the corners of the lower bumper insert area.



The light bar attaches to the OEM metal plates behind the inserts into the existing holes.

(Fig A)

Step 2: Match up the light bar brackets to the factory mounting holes through the bumper. Next, start a 1/2" x 5/8 bolt, 15/16 nut, and 2" washer and hand tighten. Repeat on other side. Installation is now complete.

CARE AND MAINTENANCE

To protect your investment it is recommended to regularly wash and wax this part. Do not use any type of cleaners that contain abrasives that may damage the finish of your part.

LIMITED WARRANTY
