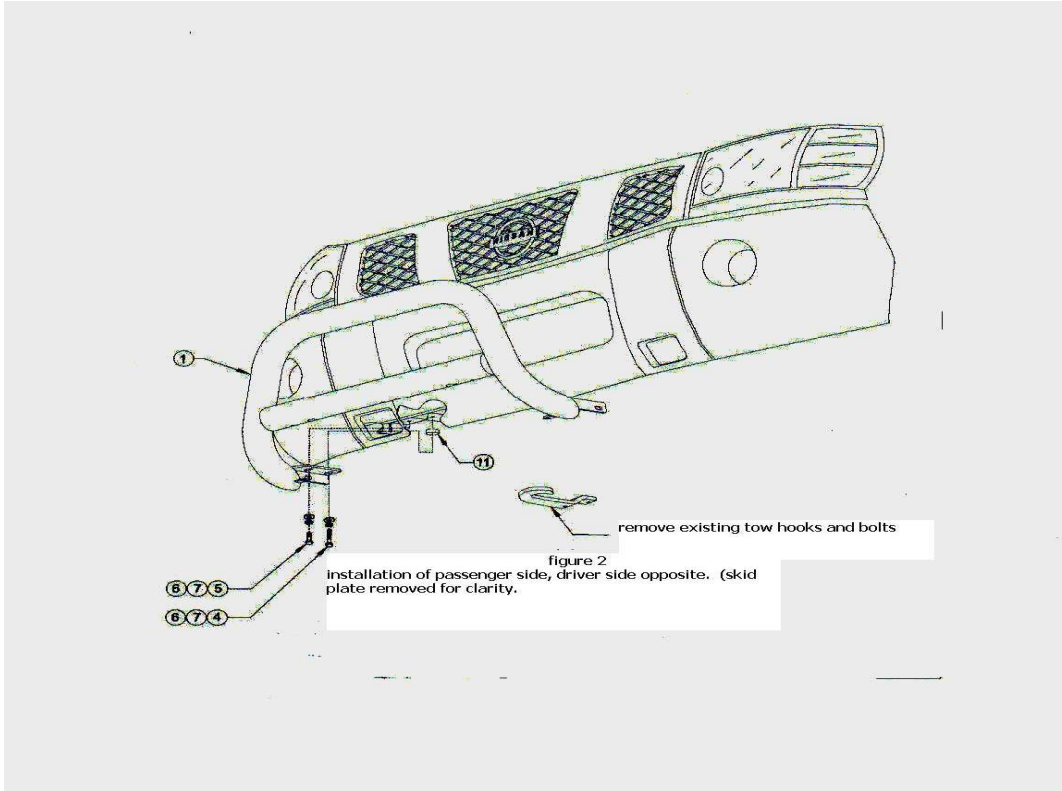

STEP 1 REMOVE CONTENTS FROM BOX AND VERIFY ALL PART ARE PRESENT. READ INSTRUCTIONS COMPLETELY BEFORE BEGINNING.

STEP 2 IT MAY BE NECESSARY TO REMOVE/RELOCATE FRONT LICENSE PLATE AND LICENSE PLATE BRACKET. IT IS NOT REQUIRED, BUT SRONGLY RECOMMENDED.

STEP 3 REMOVE TOW HOOKS BY REMOVING FRONT AND REAR TOW HOOK BOLTS. BOLTS WILL BE TIGHT. NOTE: TOW HOOKS WILL NOT BE REINSTALLED.

STEP 4 SLIDE BULL BAR ASSEMBLY THROUGH TOW HOOK OPENINGS AND ATTACH AS SHOWN.

Cleaning and Maintenance

To protect your investment, wax this product after installing. Regular waxing is recommended to add a protective layer over the finish. Do not use any type of polish or wax that may contain abrasives that could damage the finish.

For stainless steel: Aluminum polish may be used to polish small scratches and scuffs on the finish. Mild soap, window or glass cleaner may be used also.

For gloss black finishes: Mild soap, window and glass cleaner may be used.

LIMITED WARRANTY
